# Meeting Minutes June 6, 2025

- 1. Call to Order: The meeting was called to order at 10:04 am by Rebecca Cruz-Nanez, Chair.
- 2. Introductions. - a. Bob Weires announced the retirement of two positions in the Clark County School District:
  - i. Dr. Monica Cortez, Chief of Health and Student Services; retiring effective early August
  - ii. Bob Weires, Director of Psychological Services; retiring effective July
- b. Rebecca Cruz-Nanez announced that there were still spots available for the Southern Nevada Substance Misuse and Overdose Prevention Summit to be held on August 14, 2025. - **5. For possible action:** Review and approval of outstanding meeting minutes from the May 2, 2025 Main Meeting:

**MOTION:** Dan Musgrove made a motion to approve the May 2, 2025 Main Meeting Minutes.

**SECOND:** Dr. Sid Khurana

**VOTE:** Rebecca Cruz-Nanez abstained from voting due to the fact that she was not in attendance at the May 2, 2025 meeting. Approved with no opposition from remaining members.

- **6. For possible action:** Discussion, review, and possible vote on approval of transition plan for the Division of Child and Family Services Administrative and Professional Support to CCCMHC as voted on and approved at the CCCMHC Main Meeting on April 4, 2025 Karen Taycher, Chair, CCCMHC Workgroup on Infrastructure and Coordination
  - a. Karen Taycher reported that nearly everything is completed, other than a few small details to work out with Amanda and Katie, but those items can be handled in the infrastructure workgroup. She also indicated that this item was no longer needed on the agenda.
  - b. Kathryn Martin stated that they have been working closely with Amanda Haboush-Deloye to make sure Amanda has what is needed to be able to post to the Nevada public meeting website. They will continue to provide assistance until the transition is complete on June 30<sup>th</sup>.
  - c. Ms. Taycher thanked Kathryn Martin and Kary Wilder for all of their efforts to make a smooth transition and provide instruction and guidelines for administrative activities. Dan Musgrove also thanked Ms. Martin and Ms. Wilder for all of their past support and extra efforts to support CCCMHC in the transition.
- 7. For possible action: Discussion, review, and possible vote on FY26 CCCMHC Budget Karen Taycher, Chair, CCCMHC Workgroup on Infrastruction and Coordination
  - a. Karen Taycher proposed that the full consortia approve the proposed budget in the

meeting documents, requesting that they are reviewed and that any questions be directed to her. She reported that the budget includes:

- i. \$10,000 NICRP, writing reports and coordinating meetings
- ii. \$500 Our symposium
- iii. \$3125 Outreach Activities
- iv. \$15 Supplies (Amanda's team will be using existing supplies)
- v. \$375 Parent or youth stipends
- vi. \$1000 Conference or meeting attendance; Karen reports that this was left in the budget as they weren't sure whether there was going to be a special session that they might need to support a consortium member
- b. Dan Musgrove reported that a donation of \$1500 has been promised from Magellan Health, and he thanked Lisa Mariani and Magellan Health for the donation. He also thanked Karen Taycher for being the non-profit organization to accept the donation on their behalf.

**MOTION:** Char Frost made a motion to approve the FY26 CCCMHC Budget.

**SECOND:** Jackie Harris

**VOTE:** Approved with no opposition or abstention.

- **8.** Char Frost thanked NICRP for taking on the duty of transcribing the meeting minutes (*note from transcriber: you're welcome!* ②). Rebecca Cruz-Nanez also expressed her appreciation.
- **9. For information only:** These are updates from 3<sup>rd</sup> parties who are following issues related to the agency updates, legislative activities and new initiatives. No action may be taken on a matter raised under this item of the agenda until the matter itself has been specifically included.
  - a. Children's Mental Health Action Coalition, Dan Musgrove speaking on behalf.
  - b. Dan reported on the legislative updates, all of which can be found on the tracker provided by him at the meeting's conclusion here:
    - i. Monday was the final day of the 120 legislative session, commenting on procedural issues and indicating that the assembly finished on time, just before midnight.
    - ii. Provided link to Fast Democracy, showing the current status of the legislature: https://fastdemocracy.com/shared-bills/?sharing-bill-list-id=cIUNXMNC3xLk
    - iii. There are 601 Assembly bills, and 508 Senate bills, for a total of 1109 bills introduced.
    - iv. A thousand amendments introduced
    - v. 60 or so bills tracked on behalf of CMHAC
    - vi. Approx. 252 bills on the governor's desk waiting for action
    - vii. 72 bills in enrollment stage
    - viii. 33 bills vetoed
    - ix. A general statement about the 60 tracked bills was made, including AB207, a

- bill focused on mental health, addiction, equity, and parity.
- x. AB 339 did not pass
- xi. SB494 to create a new cabinet level department anchored by Medicaid; health quality and licensing
- c. Char Frost commented that they stepped back from the bill they were working on for the Clark County Regional Behavioral Health Policy Board due to a similar bill already in progress that did pass (AB442)
- d. Char also referenced an infographic that might be useful for visualizing bill progress; Lori Follett will look back and try to find it.
- e. Dan Musgrove remarked upon the issue of copyright materials from the legislative session that made it difficult to procure bill exhibits and materials after the sessions.

**Action:** Dan asked Char Frost to contact Kevin Powers at the Legislative Council Borough to discuss the legality of the copyrights.

**Question:** Bob Weiries regarding commonalities of the 33 bills that were vetoed. Dan Musgrove indicated that he would have to ask the governor directly to discuss.

iv. **Question:** Karen Taycher inquired as to whether or not the group would be planning suicide prevention activities.

Kyra Morgan responded that it is being handled under crisis response, an office to be called the Office of Crisis Response and Suicide Prevention, with Rachel Isherwood as program manager:

    - i. Margaritte Bouffard stated there was no update on the report, itself, but that reports had been given out to legislators on Children's Mental Health Day. Also indicated that it was under discussion to send them out to different boards in Southern Nevada. Next meeting is June 17<sup>th</sup>.
    - ii. Char Frost reported that photo books and copies of the report would be handed out to Clark County School District trustees.
  - b. Jackie Harris, Chair, CCCMHC Workgroup on Early Intervention and Crisis Intervention
    - i. Jackie Harris commented on the need for a re-occurring quorum in order to respond to critical incidents, rather than only meeting about them. She also expressed the need to make sure that people were being connected with services.
  - c. Karen Taycher, Chair, CCCMHC Workgroup on Infrastructure and Coordination
    - i. Karen indicated that the two necessary items fore discussion were already accomplished, above (the budget and the transition). The June meeting will be skipped, and the next meeting is July 23<sup>rd</sup>.
