FOR IMMEDIATE RELEASE — May 4, 2017 is National Children's Mental Health Awareness Day— Nevada Children's Behavioral Health Consortium Announces a Statewide Youth Video Contest Promote Mental and Emotional Health.

The U.S. Substance Abuse and Mental Health Services Administration (SAMHSA) has designated May 4, 2017 as National Children's Mental Health Awareness Day. The most recent national studies have confirmed that between 13-20 percent of American children ages 5-18 years have experienced a behavioral health disorder within the past year; over 1 in 5 adolescents have suffered severe impairment as a result of these disorders (SAMHSA, 2013). By the time U.S. children reach adulthood, approximately one-half have experienced a behavioral health need at some point in their lives. Teenagers suffer from mental health disorders at a higher rate than any other medical condition, when children's behavioral health disorders are highly treatable and even sometimes preventable. Studies have found long delays, even decades between the onset of symptoms and the identification and treatment of the disorder, which may intensify those symptoms (Merikangas et al., 2013). In a study published in 2011, over half children and youth with mental health disorders reported that they did not receive the services they needed within the past year (Merikangas et al., 2011). Whether rich or poor, insured or uninsured, the families and their children with serious behavioral health disorders struggle to find appropriate services.

In recognition of this year's National Children's Mental Health Awareness Day, the NCBHC, in collaboration with the Clark County, Washoe County, and Rural Nevada Children's Mental Health Consortia, are hosting a Youth Video Contest entitled, "Be a FORCE for Children's Mental Health." Individuals ages 18 and younger are eligible to create a 3 minute (or less) video focusing on mental health awareness. Winners will be announced April 2017 and recognized at a public video screening. BE A FORCE FOR CHILDREN'S MENTAL HEALTH YOUTH VIDEO CONTEST



The Nevada Children's Behavioral Health Consortium (NCBHC) is hosting a youth video contest to promote Children's Mental Health Awareness Day on May 4, 2017. The purpose of this contest to encourage the youth of Nevada to express their creativity as a way to help raise awareness about mental health.

Winners will be announced April 2017. A cash prize will be awarded to each regional winner and additional prizes may be awarded! One overall winner for the state will also receive a special surprise award!

Submission Instructions

DEADLINE: FRIDAY, FEBRUARY 24, 2017 BY 11:59pm (PST)

HOW TO SUBMIT: Eligible participants may enter by submitting their video via SurveyMonkey by going to www.surveymonkey.com/r/cccmhc2017 and providing the following information:

- Full names of everyone on the submitting team.
- Complete link to the unlisted YouTube video.
- Name and contact information of the Lead Producer.
- Signed release forms uploaded as attachments.

Contest Rules

To enter the contest you must agree to these official rules. Video submissions that do not abide by these rules will be disqualified.

<u>Contest Eligibility:</u> This is a youth video contest; only videos produced by individuals ages 18 and younger are eligible. Contestants may work together in groups or submit entries as individuals, but each video must have a "lead producer," who is the main point of contact.

<u>Contest Theme:</u> This year's theme is "Be a FORCE for Children's Mental Health." All videos must focus on and promote positive mental health. This may include any of the following:

• Mental health awareness.

- Preventing mental illness.
- Addressing/reducing stigma around mental health.
- Stopping bullying.
- Encourage behavior changes that ends stigma, provides support, and advocates for equal care.

<u>Time Limit</u>: Videos must be NO LONGER than 180 seconds (3 minutes) in length. This includes any opening and end credits.

<u>Submission Format</u>: Entries are limited to the following file types: MOV, MPEG4, AVI, WMV. All videos must be uploaded as an unlisted video to YouTube. NCBHC may request winning videos to be provided in other formats.

<u>Submission Language:</u> Videos must be submitted in English or with English subtitles. Contestants may submit videos in other languages, but they must contain English subtitles so that your message can be understood by everyone.

<u>Release Forms:</u> A parent of every person on the submitting team has to sign a **Video Contest Release Form**. In addition, all individuals who appear (visually or voice) in the film need to sign the **Image and Voice Release Form**. These must be scanned and uploaded during the submission process.

<u>Prizes:</u> Regional winners will be chosen from Clark County, Washoe County, and Rural Nevada. Prizes will include cash/gift cards, and a public viewing of the winning videos. One overall winner for the state will be chosen, who will receive a special surprise award! Winners may also be eligible for additional prizes.

BE A FORCE FOR CHILDREN'S MENTAL HEALTH – DO'S & DON'TS



The following rules must be followed in order for your video to be judged.

DO's...

- 1. DO get your parent's permission if you are a minor. Each Contestant who is a minor must get permission from a parent or legal guardian before shooting a video and/or entering the contest.
- 2. DO protect yours and others' privacy. If you are including names in your video, say only your first name and please don't mention anyone else's name or other personal information or include them in your Video (including appearing in or contributing to the Video) without first obtaining their written permission (or if they are a minor, the written permission of their parent/guardian).
- 3. DO be original. Feel free to put your own spin on Mental Health Awareness and the **FORCE.** Videos must be created for the purpose of entering into this contest and cannot have been submitted previously in a promotion or contest of any kind, or previously shared with the public through Email, YouTube, Facebook, Twitter, or any other means.
- 4. DO use **people-first language**, which refers to people who are living with mental health challenges as part of their full-life experience, not people who are defined by their mental health challenges (i.e. Use 'He has schizophrenia', not 'He is schizophrenic')
- 5. DO be sensitive to racial, ethnic, religious, sexual orientation and gender differences; with all individuals realistically and respectfully depicted.
- 6. DO be careful. Take caution when creating your video. Make sure not to shoot any violent activities or dangerous stunts that put you and/or others at risk of getting hurt. For your safety and the safety of others, don't try any risky moves.
- 7. DO make sure your video is suitable for public presentation. Basically, if you wouldn't want your parents or pastor to see it, it's not a video you should submit! NCBHC reserves the right to make the final determination as to the suitability for public presentation.

DON'Ts...

- 1. DON'T show any brands or logos, famous landmarks, buildings, books, works of art etc. That means no visible/recognizable use anywhere in the video of brands on clothes, sneakers, in the background, or other things which may be subject to third party intellectual property rights, such as (for example) famous landmarks, buildings, or works of art (including movie posters).
- 2. DON'T include any names and/or likenesses of any person other than you in the submission without first obtaining written permission (this includes not using images/voices of famous people). You will be responsible for getting written permission from any person included in your video (or their parent/guardian).
- 3. DON'T be rude or use profanity. **Avoid bad language, rude gestures and other inappropriate stuff**: Videos MUST NOT include nudity, obscenity, offensive language, depictions of drugs, alcohol, tobacco products, or any harmful or illegal activity; material that is fraudulent, deceptive, racially offensive, sexually explicit, threatening, hateful, or harassing.
- 4. DON'T use terms such as "crazy" and "psycho" unless explicitly communicating to the audience that these terms are unacceptable.
- 5. DON'T use any perpetuating myths or stereotypes of people living with a mental health challenge (such as: being dangerous or violent, disabled, homeless, helpless, or being personally to blame for their condition). This will help you to produce an accurate, respectful, and mindful film.
