CLARK COUNTY CHILDREN'S MENTAL HEALTH CONSORTIUM Meeting Minutes August 1, 2025

 - a. Kelly Wooldridge Working on a project that has a larger goal of looking at the long-term role of state government in children's mental health in the next legislative session. Short term goals focus on children in the highest continuum that have neurodevelopmental delays or behavioral health issues that maybe aren't receiving the services they need. - **6. For information only:** System of Care Grant Update Meambi Newbern-Johnson & Heather Heuke
 - a. Meambi Newbern-Johnson reported that a full grant team has been developed including Alicia Hines, Heather Heuke, and Eva Romero.
 - b. Alicia Hines shared a presentation updating members on the System of Care grant, the new department structure, and the cultivating of strong partnerships with those departments present. Full slides are available with meeting materials.
 - c. Kyra Morgan expressed her appreciation for the presentation and offered to assist in expanding the cooperation between the highest levels.
 - d. Richard Egan also expressed his appreciation and the Office of Suicide Prevention as a resource for them as well.
 - e. Amanda Haboush-Deloye provided information covered by NICRP that might also be helpful for topics such as toxic stress, ACES, and positive childhood experiences.
 - f. Karen Taycher commented that the DCFS and county and state system of care grants should be collaborating. She also offered Nevada PEP as a resource if needed.

 - a. Karen Taycher reported that the budget was approved by DCFS.
 - b. Amanda Haboush-Deloye reported that the Scope of Work was completed and submitted.

 - a. Children's Mental Health Coalition:
 - Rebecca Cruz-Nanez received an e-mail regarding activities that she will be forwarding to the group. Highlights include an invitation for the family data release,

a list of back-to-school fairs, and that the 2025 Kids Count data book is available.

b. 988 Planning Workgroup

- Rebecca Cruz-Nanez reported that she has attending meetings, but has been unable
 to join the committees that were formed. She indicated that progress is low, right
 now.
- Char Frost raised concerns about the federal government removing funding for the program, but Karen Taycher reported that a recent e-mail from their national association reported that the funding was saved, although it is not final.
- Carley Murray reported that the subgroup she attended (Someone to Respond: Mobile Crisis Group) was focused on compiling all crisis response teams statewide, but that they are having difficulties getting information from Clark County, specifically. She also indicated that if the other two subgroups are not being attended, this group should coordinate to have someone attend those in order to report back here.
- Jackie Harris stated that she was assigned to the subgroup A Safe Place for Help, so two of the subgroups are covered. She has not attended a meeting, yet, but will be attending the next.
- c. Medicaid Workshop on Transforming Behavioral Health Care for Nevada Children
 - Dan Musgrove reported that the new director, Stacie Weeks, ran the meeting, which was a stakeholder update on the new Nevada Health Authority created by SB 494. PowerPoint slides are linked in chat.
 - Char Frost reported a few notable items, such as the removal of Medicaid coverage for DACA recipients, and the lack of a clear message regarding how the Health Authority is collaborating with DPBH and DCFS.
 - Karen Taycher invited anyone who concerns regarding what they heard to come to the Infrastructure meeting to assist with developing the group's priorities for the upcoming year.
